WHEREAS, the requested funding will allow Rancho Bernardo Business Association to pursue renaming Calle Saucillo to Bob Wells Way, in honor of Mr. Bob Wells who was a founding member of many Rancho Bernardo organizations such as the RB Chamber of Commerce and the RB Community Foundation; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06, Community Projects, Programs and Services; and

WHEREAS, Council District 5 recommends an allocation of \$2,500 to Rancho Bernardo Business Association for the purposes set forth herein; NOW, THEREFORE,

an amount not to exceed \$2,500 from the Community Projects, Programs and Services budget

Fund No. 100000, Cost Center 1105110005, to provide funds for the above-referenced

agreement, contingent upon the City Comptroller first furnishing one or more certificates

certifying that the funds necessary for expenditure are, or will be, on deposit with the City

Treasurer.
