WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-23, entitled "City Council Funding of Arts, Culture and Community Festivals with Transient Occupancy Tax Allocation" on August 13, 2012, by Resolution R-307625; and

WHEREAS, among other things, Council Policy 100-23 provides a procedure and uniform requirements for awarding funds to and contracting with private nonprofit organizations that produce programs, projects and events that (i) provide access to excellence in culture and the arts for residents of, and visitors to, San Diego, and (ii) enrich the lives of the people of San Diego and build healthy, vital neighborhoods; and

WHEREAS, Justice Overcoming Boundaries (JOB) in San Diego County (JOB SD) has requested funding for its Fiesta del Sol San Diego, which event offers residents and visitors safe, fun, family-oriented entertainment via live music from local and international artists, as well as resource pavilions in the areas of education, green technology, health and civic engagement (Project); and

WHEREAS, it is the determination of the City Council that the Project fits within the parameters of Council Policy 100-23; and

WHEREAS, Council District 8 recommends an allocation of \$1,000 to JOB SD for the purposes set forth herein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation

described herein will assist JOB SD in producing the Project.

BE IT FURTHER RESOLVED, that the Council hereby waives section 3(g) of Council

Policy 100-23, which provides that an organization may not apply to receive funding for an event

or program which has already occurred, nor any goods, supplies or materials which have already

been purchased.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is directed to execute,

for and on behalf of the City, an agreement with JOB SD in an amount not to exceed \$1,000 for

the Project, in accordance with the terms and conditions set forth in the agreement on file in the

Office of the City Clerk as Document No. RR- 308179

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$1,000 from the Transient Occupancy Tax Fund No. 200205, Cost

Center 1414111219, to provide funds for the above-referenced agreement, contingent upon the

City Comptroller first furnishing one or more certificates certifying that the funds necessary for

expenditure are, or will be, on deposit with the City Treasurer.
