A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$7,000 TO I LOVE A CLEAN SAN DIEGO FOR ITS 11TH ANNUAL CREEK TO BAY CLEANUP, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, entitled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by Resolution R-306903; and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural or recreational needs which serve a lawful public purpose; and

WHEREAS, I Love a Clean San Diego has requested funding for its 11th Annual Creek to Bay Cleanup; and

WHEREAS, the requested funding will allow I Love a Clean San Diego to provide outreach materials to recruit volunteers for cleanup events, as well as the rental of event equipment including a U-Haul truck, a public address system, and temporary toilets; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06, Community Projects, Programs and Services; and

WHEREAS, Council District 1, 2, 3, 5, 6, 7, and 8 recommend an allocation of \$7,000 to I Love a Clean San Diego for the purposes set forth herein attributed as follows: Council District 1 - \$1,000; Council District 2 - \$1,000; Council District 3 - \$1,000; Council District 5 - \$1,000; Council District 6 - \$1,000; Council District 7 - \$1,000; and Council District 8 - \$1,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described herein is made for a public purpose.

BE IT FURTHER RESOLVED, that the Council hereby waives Council Policy 100-06, 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is directed to execute for and on behalf of the City, an Agreement with I Love a Clean San Diego in an amount not to exceed \$7,000 for the project described herein, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 308185

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$7,000 from the Community Projects, Programs and Services budget Fund No. 100000, Cost Center 1101110001 for \$1,000; and Cost Center 1102110002 for \$1,000; and Cost Center 1103110003 for \$1,000; and Cost Center 1105110005 for \$1,000; and Cost Center 1106110006 for \$1,000; and Cost Center 1107110007 for \$1,000; and Cost Center 1108110008 for \$1,000, to provide funds for the above-referenced agreement, contingent upon

the City Comptroller first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
