DATE OF FINAL PASSAGE MAY 16 2013

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO INCREASING THE SUNSET CLIFFS CIP
FUNDING FOR EMERGENCY CLEANUP OF A PUBLIC
NUISANCE.

WHEREAS, a public nuisance exists due to a fire that occurred in April 2013 at vacant structures on Ladera Street within Sunset Cliffs Natural Park and requires emergency cleanup and demolition; and

WHEREAS, City staff have taken measures to secure the premises, but permanent remediation is necessary; and

WHEREAS, the City has an on-call contractor to provide the necessary remediation, and funding is available, subject to Council approval; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That in accordance with the annual appropriation ordinance, the Chief Financial Officer is authorized to amend the Fiscal Year 2013 Capital Improvement Program budget to increase CIP S-10091, Sunset Cliffs Natural Park Hillside Improvements, by the amount of \$200,000.

2. That the Chief Financial Officer is authorized to transfer the amount of \$200,000 from Fund No. 200463, Sunset Cliffs Natural Park Fund, to CIP S-10091, Sunset Cliffs Natural Park Hillside Improvements.

3. That the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$200,000 from CIP S-10091, Sunset Cliffs Natural Park Hillside Improvements, solely and exclusively for the emergency cleanup, demolition, and removal of a public nuisance

at 4401 Ladera Street within Sunset Cliffs Natural Park, provided that the Chief Financial Officer furnishes a certificate demonstrating that the funds for this expenditure are, or will be, on deposit in the City Treasury.




