WHEREAS, it is the policy of the City of San Diego to establish fees to recover the costs of providing services in accordance with San Diego Administrative Regulation 95.25 and Council Policy 100-05 "User Fee Policy"; and

WHEREAS, Ordinance No. O- 20261 , which is considered along with this resolution, amends San Diego Municipal Code section 141.0621 to allow sidewalk cafes as a limited use in certain zones and requires an annual inspection of sidewalk cafes in order to ensure compliance with the limited use regulations for sidewalk cafes; and

WHEREAS, the Development Services Department evaluates the costs associated with providing services for which fees are charged; and

WHEREAS, the City Council adopted the current Development Services Department Fee Schedule on October 13, 2009; and

WHEREAS, the Development Services Department Fee Schedule reflects the estimated reasonable cost of providing the service for which the fees are charged as set forth in Report No. 09-090; and

WHEREAS, the rate for an hourly inspection is currently One Hundred Twenty-Two Dollars and Ninety-Two Cents (\$122.92); NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that provided that Ordinance No. 20261 becomes effective, the fee for annual inspections of sidewalk

cafes shall be the rate for an hourly inspection as set forth in the most recent Development Services Department Fee Schedule.
