A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AN AMENDMENT TO THE TIERRASANTA COMMUNITY PLAN TO IMPLEMENT THE SAN DIEGO RIVER PARK MASTER PLAN AND TO AMEND THE GENERAL PLAN.

WHEREAS, on MAY 2 0 2013, the City Council of the City of San Diego held a public hearing for the purpose of considering an amendment to the Tierrasanta Community Plan (Community Plan) adopted on July 27, 1982, Resolution No. 256890, and including its subsequent amendments, to implement the San Diego River Park Master Plan; and

WHEREAS, the 2008 General Plan will be amended due to the Community Plan being part of the Land Use Element of the adopted General Plan; and

WHEREAS, on April 18, 2013, the Planning Commission of the City of San Diego held a public hearing to consider actions associated with adoption of the San Diego River Park Master Plan, including this amendment to the Community Plan; and

WHEREAS, the Planning Commission recommended certification of the Program Environmental Impact Report No. 121886, which addressed the community plan amendment; and

WHEREAS, the Planning Commission found, based on its hearing record, that this amendment retains internal consistency with the Community Plan and the 2008 General Plan, and that the proposed amendment helps achieve long-term community and citywide goals; and

WHEREAS, the City Council has considered the Planning Commission record and recommendation as well as all maps, exhibits, and written documents contained in the file for this amendment on record in the City of San Diego, and has considered the oral presentations given at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council adopts the amendments to the General Plan and the Tierrasanta Community Plan, a copy of which is on file in the office of the City Clerk as Document No. RR-308198, which adoption shall be effective after final passage of O-20253, O-20254, and O-20255, ordinances related to implementation of the San Diego River Park Master Plan project.
