A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AN AMENDMENT TO THE MISSION TRAILS DESIGN DISTRICT DESIGN MANUAL OF THE LAND DEVELOPMENT MANUAL TO IMPLEMENT THE SAN DIEGO RIVER PARK MASTER PLAN.

WHEREAS, on MAY 20 2013, the City Council of the City of San Diego held a public hearing for the purpose of considering an amendment to the Mission Trails Design District Design Manual (Design Manual), part of the Land Development Manual, as adopted on July 28, R-254722, and including its subsequent amendments, to implement the San Diego River Park Master Plan; and


WHEREAS, on April 18, 2013, the Planning Commission of the City of San Diego held a public hearing to consider actions associated with adoption of the San Diego River Park Master Plan, including this amendment to the Design Manual, and recommended this amendment;

NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council adopts the amendments to the Mission Trails Design District Design Manual and Land Development Manual, a copy of which is on file in the office of the City Clerk as Document No.

RR- 308201, which adoption shall be effective after final passage of O- 20263,
O- 20264, and O- 20265, ordinances related to implementation of the
San Diego River Park Master Plan project.
