DATE OF FINAL PASSAGE JUN 05 2013

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AND DIRECTING THE MAYOR TO ENTER INTO AN AGREEMENT WITH MUNICIPAL EMERGENCY SERVICES, INC. TO FURNISH THE CITY WITH SELF-CONTAINED BREATHING APPARATUSES FOR AN AMOUNT OF UP TO \$1,681,259.89.

WHEREAS, the provision of Personal Protection Equipment (PPE) is mandated by the United States Department of Labor; and

WHEREAS, a Self-Contained Breathing Apparatus (SCBA) is an essential PPE component that City employees use during confined space entries and other hazardous environments that are immediately dangerous to life and health; and

WHEREAS, SCBA equipment is most frequently used by City employees in the Fire-Rescue, Public Utilities, and Transportation and Storm Water Departments; and

WHEREAS, the City may need to purchase up to 110 SCBAs annually as part of routine equipment replacement; and

WHEREAS, 720 SCBA bottles will expire over the duration of this agreement and an additional 777 SCBA masks will need to be purchased over the next five years; and

WHEREAS, on September 14, 2012, the City issued a request for bids to furnish the City with Scott SCBAs, including parts and maintenance, through the City's request for bids process; and

WHEREAS, Municipal Emergency Services, Inc. (MES) responded with the lowest price offering; and

WHEREAS, the City is requesting the City Council to authorize entering into an agreement with MES to furnish the City with SCBAs, including parts and maintenance, for an amount not to exceed \$1,681,259.89; and

WHEREAS, this agreement with MES is for an initial one-year term, and may be extended for four one-year additional periods; and

WHEREAS, the funds are currently budgeted within the Fire-Rescue, Public Utilities, and Transportation and Storm Water Departments; and


WHEREAS, no additional funds are being requested for the duration of the contract;
NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego that the Mayor or his designee is authorized and directed to approve and execute a one-year agreement, with the option to renew for up to four additional one-year periods, with Municipal Emergency Services, Inc. to furnish the City of San Diego with Scott Self-Contained Breathing Apparatuses, under the terms and conditions of that agreement on file with the Office of the City Clerk as Document Number RR- 308203.

BE IT FURTHER RESOLVED, that the Mayor or his designee is authorized to expend an amount not to exceed \$1,681,259.89, including up to \$41,000 in FY 2013 funds, throughout the duration of this agreement with Municipal Emergency Services, Inc., contingent upon the

adoption of the Annual Appropriations Ordinance for the applicable fiscal year, and contingent upon certification from the Chief Financial Officer that the funds are available.


