A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$3,800 TO CREATIVE PERFORMING ARTS (PTA) FOR VISUAL AND PERFORMING ARTS INSTRUCTION AND PERFORMANCES, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, entitled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by Resolution R-306903; and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural or recreational needs which serve a lawful public purpose; and

WHEREAS, Creative Performing Arts (PTA) has requested funding for Visual and Performing Arts Instruction and Performances; and

WHEREAS, the requested funding will allow Creative Performing Arts (PTA) to provide advanced instruction for students in band and orchestra, as well as to fund costumes and other materials for stage and dance productions; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06, Community Projects, Programs and Services; and

WHEREAS, Council District 6 recommends an allocation of \$3,800 to Creative Performing Arts (PTA) for the purposes set forth herein; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described herein is made for a public purpose.

BE IT FURTHER RESOLVED, that the Council hereby waives Council Policy 100-06, section 3(g) which provides that an organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased.

BE IT FURTHER RESOLVED that the Mayor, or his designee, is directed to execute, for and on behalf of the City, an Agreement with Creative Performing Arts (PTA) in an amount not to exceed \$3,800 for the project described herein, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 30821.3

BE IT FURTHER RESOLVED that the Chief Financial Officer is authorized to expend an amount not to exceed \$3,800 from the Community Projects, Programs and Services budget Fund No. 100000, Cost Center 1106110006, to provide funds for the above-referenced agreement, contingent upon the City Comptroller first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.






