BE IT FURTHER RESOLVED, that the Council hereby waives Council Policy 100-06, 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is directed to execute for and on behalf of the City, Agreements with (1) Mission Hills Town Council in an amount not to exceed \$5,000; (2) San Diego Military Advisory Council in an amount not to exceed \$6,000; and (3) Greater San Diego Tennis Council in an amount not to exceed \$2,310; for the projects described herein, under terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document Nos. BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend the amounts described herein from the Community Projects, Programs and Services budget Fund No. 100000, Cost Center 1103110003 for \$5,000 (Mission Hills Town Council), for \$1,500 (SDMAC), and for \$2,310 (Greater San Diego Tennis Council); and Cost Center 1102110002 for \$1,500 (SDMAC); Cost Center 1106110006 for \$1,500 (SDMAC); Cost Center 1108110008 for \$1,500 (SDMAC) to provide funds for the above-referenced agreements, contingent upon the

City Comptroller first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
