A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AMENDING THE CLASSIFICATIONS PREVIOUSLY DESIGNATED BY THE CITY COUNCIL AS APPROPRIATELY ASSIGNED TO EMPLOYEE REPRESENTATION UNITS TO REFLECT CHANGES TO CLASSIFICATION TITLES AND REMOVAL OF DELETED CLASSIFICATIONS, SUCH AMENDMENTS TO BE AS CONTAINED IN THE LISTING OF JOB CLASSIFICATIONS AND APPROPRIATE UNITS.

WHEREAS, the Council of the City of San Diego (City Council) has formally recognized various employee organizations to represent employees in appropriate units established in accordance with the Meyers-Milias-Brown Act and the City's Employee-Employer Relations Policy, set forth in City Council Policy 300-06; and

WHEREAS, the Fiscal Year 2014 Salary Ordinance contains classification title changes, specifically the Police Investigative Aide I is retitled to Police Investigative Service Officer I, and the Police Investigative Aide II is retitled to Police Investigate Service Officer II; these classifications remain represented by the San Diego Municipal Employees' Association (MEA); and

WHEREAS, it is also now necessary to remove deleted classifications from existing appropriate units, specifically Bindery Worker I, Bindery Worker II, Bindery Worker III, which were represented by Local 127, American Federation of State, County, and Municipal Employees, and Payroll Audit Supervisor – Personnel, which was represented by MEA; NOW THEREFORE,

BE IT RESOLVED, by the City Council, that the classifications previously designated by the City Council as appropriately assigned to employee representation units be amended to reflect removal of deleted classes and changes to classification titles, such amendments to be as contained in the listing of job classifications and appropriate units, as set forth in Attachment A to this Resolution.


