A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO IN SUPPORT OF THE DEVELOPMENT OF AN INTERNATIONAL BOUNDARY AND WATER COMMISSION (IBWC/CILA) MINUTE TO THE 1944 U.S.-MEXICO WATER TREATY TO REDUCE THE TRANS-BORDER FLOW OF TRASH, SEDIMENT, AND WASTEWATER IN THE TIJUANA RIVER WATERSHED.

WHEREAS, the Tijuana River Watershed is a shared binational watershed of 1,739 square-miles, with one-fourth in the United States and three-fourths in Mexico, that empties into the Pacific Ocean in San Diego, California; and

WHEREAS, the International Boundary and Water Commission/Comisión Internacional de Límites y Agua (IBWC/CILA) has discussed development of a minute to the 1944 U.S.-Mexico Water Treaty to allow both the U.S. and Mexico to bi-nationally address the issues of trash, sediment and water quality in the Tijuana River Watershed; NOW, THEREFORE,

BE IT RESOLVED, by the City of San Diego that the City supports the effort of the IBWC/CILA to develop a new minute to the 1944 U.S.-Mexico Water Treaty to reduce the trans-border flow of trash, sediment, and wastewater in the Tijuana River Watershed.


