A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO DECLARING THE RESULTS OF THE SPECIAL
RUN-OFF ELECTION HELD IN COUNCIL DISTRICT 4 IN
THE CITY OF SAN DIEGO ON MAY 21, 2013

WHEREAS, a Special Run-off Election was held in Council District 4 in the City of San Diego on Tuesday, May 21, 2013, pursuant to the provisions of Ordinance No. O-20250 (New Series), introduced and adopted on March 28, 2013, for the purpose of electing a Councilmember for the office of Councilmember for District 4; and

WHEREAS, a copy of the certificate of the Registrar of Voters of San Diego County canvassing the returns of the Special Run-off Election, as certified to the City Clerk, has been duly received; and

WHEREAS, the City Clerk has certified the results to the City Council; and

WHEREAS, declaring the results of the election as certified by the Registrar of Voters and the City Clerk is a ministerial act required by California Elections Code section 10263 and, therefore, is not subject to veto by the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council finds and determines, pursuant to the provisions of Section 27.0411 of the San Diego Municipal Code, as follows:

I

The total number of votes cast in the Special Run-off Election was 12,215.

II

The total vote received by each candidate at the Special Run-off Election is as follows:

FOR COUNCIL DISTRICT 4 (filling the vacancy in the term previously held by

Anthony Young):

MYRTLE COLE	6,612 VOTES (54.13%)
DWAYNE CRENSHAW	5,603 VOTES (45.87%)
Total	12,215 VOTES (100%)

Myrtle Cole is hereby declared to be elected to the Office of Council District 4 in the Special Run-off Election.

III

The City Clerk shall make public the results of the canvass of the Special Run-off Election by publication of a copy of this resolution.
