A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING AN AGREEMENT WITH  
SANDAG FOR THE TRANSIT TRAFFIC SIGNAL PRIORITY  
MAINTENANCE PROJECT.

WHEREAS, the Metropolitan Transit System (MTS) operates bus routes 201, 202, and 204 in the University City area, collectively known as the "Super Loop"; and

WHEREAS, the City and the San Diego Association of Governments (SANDAG) now desire to increase the efficiency of the MTS Super Loop by providing priority to MTS buses at City traffic signals; and

WHEREAS, this agreement provides for SANDAG to reimburse the City for expenses incurred by City staff providing operational and maintenance support to the City traffic signals along the Super Loop; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego: that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, an Agreement with SANDAG, for the maintenance and operation of priority traffic signals in connection with the Super Loop transit project, under the terms and conditions set forth in the Agreement, on file in the Office of the City Clerk as Document No. RR 308230
