A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE TRANSFER OF FUNDS TO THE RIMBEY AVENUE LIGHTED CROSSWALK AND IRIS AVENUE SIDEWALK PROJECTS.

WHEREAS, in Fiscal Year 2009, the City submitted applications to the State of California for the Safe Routes to School (SR2S) program to encourage walking and bicycling to schools; and

WHEREAS, the City received \$453,410 from the SR2S program for pedestrian safety improvements in the Nestor Community near Berry Elementary, Emory Elementary, Nestor Elementary, and Mar Vista Schools; and

WHEREAS, TransNet funds in the amount of \$67,500 were identified as matching funds to the grant; and

WHEREAS, construction of the projects associated with the SR2S grant has been completed and a balance of \$325,431.64 is remaining; and

WHEREAS, this action proposes to allocate the remaining SR2S grant funding to the Rimbey Avenue Lighted Crosswalk and Iris Avenue Sidewalk projects and release a like amount of TransNet funding for reallocation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That Chief Financial Officer is authorized to transfer an amount not to exceed
 \$325,431.64 from CIP L-00010, SR2S bulb out, curb ramp, signs Grant #1, Grant
 #1000308-2010, to two projects, of which \$170,000 is for A-IL.00001, Traffic Calming (Rimbey)

Avenue Lighted Crosswalk – sublet B-00995), and \$155,431.64 is for A-IK.00001, New Walkways (Iris Avenue Sidewalks – sublet B-10158), within Fund 600001, State Grant.

- 2. That the Chief Financial Officer is authorized to transfer an amount not to exceed \$52,825.18 from CIP L-00010, SR2S bulb out, curb ramp, signs Grant #1, to CIP A-1K.00001, New Walkways, within Fund 400169, TransNet Extension.
- 3. That the City Comptroller, upon advice from the administering department, is authorized to transfer excess budgeted funds, if any, to the appropriate reserves.
