DATE OF FINAL PASSAGE JUN 14 2013

A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING EXPANSION OF THE PERMIT  
PARKING AREA "D" IN THE BARRIO LOGAN  
COMMUNITY PLAN AREA.

WHEREAS, Residential Permit Parking Area "D" in the Barrio Logan Plan area was established in 2001; and

WHEREAS, the City Council approved an expansion to the Area "D" Permit Parking Area on July 13, 2010, by Resolution No. R-305956; and

WHEREAS, parking usage and occupancy studies performed in recent years and corroborated by field inspections performed by Traffic Engineering staff have determined that the subject area is severely impacted by all-day commuter parking; and


WHEREAS, separate petitions representing a majority of affected residences have provided support for an expansion of the Permit Parking Area "D"; and

WHEREAS, a public hearing was held on March 13, 2013, and the residents present voiced full support for the proposed expansion; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that pursuant to authority conferred by and in accordance with the provisions of San Diego Municipal Code section 86.2005(b), expansion to existing Residential Permit Parking Area "D" to include 2121 and 2123 Newton Avenue, the east side of South Evans Street from the alley north of National Avenue to approximately 90 feet south of the alley to include 925,927 and 929 South Evans Street, and the west side portion of South Evans from the alley north of National Avenue to National Avenue and to include 928 South Evans Street and 2090 National Ave.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.




