A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ACCEPTING THE CITY OF SAN DIEGO
DEVELOPMENT IMPACT FEES FISCAL YEAR 2012
ANNUAL REPORT AND MAKING FINDINGS RELATED TO
UNEXPENDED BALANCES AS REQUIRED BY
CALIFORNIA GOVERNMENT CODE SECTION 66001

WHEREAS, California Government Code section 66006 requires local agencies to make certain information available to the public on an annual basis with respect to imposition of development impact fees; and

WHEREAS, California Government Code section 66001 further provides that certain findings must be made with respect to any development impact fees collected and remaining unexpended in their fifth year after collection and every five years thereafter; and


WHEREAS, the City of San Diego imposes development impact fees in connection with approval of development projects; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that it has reviewed and accepts the "City of San Diego Development Impact Fees FY 2012 Annual Report," a copy of which is on file in the Office of the City Clerk as Document No. RR- 308264 (Annual Report).

BE IT FURTHER RESOLVED, that the Council finds, with respect to funds reflected in the Annual Report as having been collected over five years before July 1, 2012 and as stated in Section 2 and Attachment 7 of the Annual Report, that the documentation: (1) identifies the purpose to which the fee is to be put; (2) demonstrates a reasonable relationship between the fee and the purpose for which it is charged; (3) identifies sources and amounts of funding anticipated

to complete financing of incomplete improvements; and (4) identifies the approximate dates on which such funding is expected to be deposited into the appropriate fund, and incorporates and adopts such findings.


