A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO PRELIMINARILY APPROVING THE UPDATES TO THE ASSESSMENT ENGINEER'S REPORTS SUBMITTED IN CONNECTION WITH THE CITY-MANAGED MAINTENANCE ASSESSMENT DISTRICTS FOR FISCAL YEAR 2014.

WHEREAS, the City formed each Maintenance Assessment District ("MAD") specified below pursuant to Article XIID of the California Constitution, the Proposition 218 Omnibus Implementation Act (California Government Code section 53750 *et seq.*), the Landscape and Lighting Act of 1972 (California Streets and Highways Code section 22500 *et seq.*), and the Maintenance Assessment Districts Ordinance (San Diego Municipal Code section 65.0201 *et seq.*); and

WHEREAS, as part of the formation process, an assessment engineer prepared written reports ("Engineer's Reports") on the following City-managed MADs:

WHEREAS, each year the City Council approves the continued levy of assessments within the City's MADs for the new fiscal year, and authorizes the appropriation and expenditure of the assessment funds; and

WHEREAS, each year the City Council also approves certain updates to the Engineer's Reports, such as: modifying the assessment rates within the approved assessment formula for cost indexing, maximum assessment rates, and reserve limits; identifying property and land use changes that may impact the calculation of the assessment rate; reviewing the scope of services for improvements to comply with the approved assessment methodology; incorporating general benefit rates proposed for the new Fiscal Year; and integrating the proposed budget for the new Fiscal Year; and

WHEREAS, an assessment engineer has prepared such updated reports for the period of July 1, 2013 through June 30, 2014 (“Fiscal Year 2014”) to be considered by the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the updated Engineer’s Reports submitted for Fiscal Year 2014 in connection with the City-managed Maintenance Assessment Districts and filed in the Office of the City Clerk as follows are hereby preliminarily approved as filed:
