A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING TO EXECUTE AN AGREEMENT
WITH SIMON WONG ENGINEERING, INC. FOR THE
ASSESSMENT OF POTABLE WATER RESERVOIRS.

WHEREAS, the City of San Diego Public Utilities Department [Department] owns and operates 33 potable water reservoirs, and the Department is in the process of accelerating its condition assessment program; and

WHEREAS; in June 2012, the Department requested proposals from qualified firms for a contract to assess the condition of 12 potable water reservoirs; and

WHEREAS; in September 2012, the Department's Selection Panel interviewed five engineering firms and the Department selected Simon Wong Engineering Inc. as the most qualified firm; and

WHEREAS; the proposed agreement between The City of San Diego and Simon Wong Engineering Inc. for the Assessment of Potable Water Reservoirs has a total cost value not-to-exceed of \$1,249,205 for a duration of four (4) years; NOW, THEREFORE


BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the Mayor, or his designee, is directed to award and execute, for and on behalf of the City, an agreement with Simon Wong Engineering, Inc. for the Assessment of Potable Water Reservoirs in an amount not to exceed \$1,249,205 for the duration of four (4) years, under the terms and conditions set forth in the agreement, on file in the Office of the City Clerk as Document No. RR 308274 [Agreement], contingent upon adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon City Comptroller

furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and

2. That the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$1,249,205 from Water Operating Fund 700011, solely and exclusively to provide funds for the above Agreement provided that the City Comptroller furnishes one or more certificates demonstrating that the funds for this expenditure are, or will be, on deposit in the City Treasury and contingent upon adoption of the Annual Appropriation Ordinance for the applicable fiscal year.






