
A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE AGREEMENT WITH BLACK AND VEATCH CORPORATION FOR CONSULTANT SERVICES FOR THREE WATER TRANSMISSION PIPELINE CONDITION ASSESSMENT; AND TAKING RELATED ACTIONS.

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized and directed to execute the four-year agreement with Black and Veatch Corporation for consulting services for Three Water Transmission Pipeline Condition Assessment for an amount not to exceed \$2,999,946, under the terms and conditions set forth in the document filed with the City Clerk as Document No. RR- 308276

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$2,999,946 from Water Operating Fund 700011 for the purpose of funding the above agreement, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer furnishing one or more certificates demonstrating that the funds for this expenditure are, or will be, on deposit in the City Treasury.


