A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO TO ADOPT COUNCIL POLICY 000-32  
ENTITLED "NEIGHBORHOOD INPUT ON  
INFRASTRUCTURE NEEDS AND PRIORITIES."

WHEREAS, pursuant to Council Policy 000-01, the City Council (Council) is charged with the responsibility of establishing municipal policies to guide the various functions of the City of San Diego (City); and

WHEREAS, community planning groups were formed by Council Policy 600-24 and recognized by the Council to provide ground level organization for every neighborhood within the City as well as make recommendations to the Council and City staff; and

WHEREAS, the Community Planners Committee (CPC) was formed under Council Policy 600-09 to advise the Council on citywide matters and consists of the chairs of the planning groups; and

WHEREAS, Public Works staff, before drafting the Fiscal Year 2014 Capital Improvement Program (CIP) budget, conducted the first-ever public process to gain community input on infrastructure suggestions and priorities; and

WHEREAS, this public process was organized under the CPC and implemented by the community planning groups, by conducting public outreach, providing a forum for discussion, and building consensus for recommendations; and

WHEREAS, proposed Council Policy 000-32 "Neighborhood Input on Infrastructure Needs and Priorities" was developed to formalize a role and process for neighborhood input on


infrastructure needs and priorities for consideration in the City's multi-year infrastructure plan;

NOW, THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego hereby adopts Council Policy 000-32, entitled "Neighborhood Input on Infrastructure Needs and Priorities," on file with the City Clerk's office as Document No. RR- 308287, and fully incorporated into this resolution by reference.

BE IT FURTHER RESOLVED, that the City Clerk is instructed to add Council Policy 000-32 to the Council Policy Manual.


