A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE APPROVAL OF A SECOND AMENDMENT TO THE CONSULTANT AGREEMENT WITH SIMON WONG ENGINEERING FOR PROFESSIONAL ENGINEERING SERVICES RELATED TO THE TED WILLIAMS PARKWAY OVERCROSSING AT SHOAL CREEK PROJECT IS EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY (CEQA) PURSUANT TO CEQA GUIDELINES SECTION 15060(C)(2).

WHEREAS, this action will amend and extend a Consultant Agreement for Simon Wong Engineering, Inc. to provide professional engineering services for the Ted Williams Parkway Pedestrian Bridge at Shoal Creek Project; and

WHEREAS, the professional engineering services subject to this amendment are to provide engineering support to the on-going construction of the pedestrian bridge over the Ted Williams Parkway at Shoal Creek and will not result in any additional physical change in the environment; and


WHEREAS, the Council of the City of San Diego has considered the potential environmental effects of this Second Amendment to the Consultant Agreement with Simon Wong Engineering, Inc.; and

WHEREAS, the Council of the City of San Diego, using its independent judgment, has determined that this action will not have a significant effect on the environment; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Second Amendment to the Consultant Agreement with Simon Wong Engineering, Inc. is exempt from CEQA pursuant to CEQA Guidelines section 15060(c)(2).


