
DATE OF FINAL PASSAGE JUL 19 2013

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE AGREEMENT WITH TRAN CONSULTING ENGINEERS FOR CONSULTANT SERVICES FOR THE PROGRAMMATIC WASTEWATER PIPELINES CONDITION ASSESSMENT PROJECT FOR 2013-2017; AND TAKING RELATED ACTIONS.

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to execute the five-year agreement with Tran Consulting Engineers for consulting services for the Programmatic Wastewater Pipelines Condition Assessment (2013-2017) project, for an amount not to exceed \$8,000,000, under the terms and conditions set forth in the document filed with the City Clerk as Document No. RR- 308326.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$8,000,000 from Sewer Operating Funds 700000 and 700001 for the purpose of funding the above agreement, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer furnishing one or more certificates demonstrating that the funds for this expenditure are, or will be, on deposit in the City Treasury.


