A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE INSTALLATION OF
ANGLE PARKING ON THE EAST SIDE OF 38TH
STREET NORTH OF DWIGHT STREET.

WHEREAS, the Transportation Engineering Operations Division of the Transportation
and Stormwater Department has received a request to convert parallel parking to angled parking
on the east side of 38th Street north of Dwight Street; and


WHEREAS, the Transportation Engineering Operations Division has calculated that
thirty nine additional parking spaces could be created by the installation of angled parking on the
east side of 38th Street north of Dwight Street; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that in accordance with
San Diego Municipal Code section 86.03 and California Vehicle Code section 22503, the
installation of angle parking on east side of 38th Street north of Dwight Street is authorized.

BE IT FURTHER RESOLVED, that the installation of necessary signs and marking for
such angle parking is authorized, and the regulations shall become effective on installation of the
signs.

BE IT FURTHER RESOLVED, that installation of angled parking would be done as part
of CIP S-00930, 38th Street Cul-De-Sac Improvements.




