A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO APPROVE ACCEPTING FUNDS FROM THE HIGHWAY SAFETY IMPROVEMENT PROGRAM FOR THE ULRIC STREET FASHION HILLS TO DAVID STREET, K-RAIL PROJECT.

WHEREAS, the Highway Safety Improvement Program (HSIP) is a federal grant that is managed by the California Department of Transportation (Caltrans), which funds public bicycle and pedestrian pathway or trail projects; and

WHEREAS, in 2008, Transportation Engineering staff performed a safety evaluation and accident analysis on Ulric Street between David Street and Fashion Hills Boulevard, in the community of Linda Vista, as part of the City's accident surveillance program; and

WHEREAS, this safety analysis revealed that there has been a pattern of collisions reported on the subject segment of Ulric Street, where drivers had crossed over the painted center median into opposing traffic causing head-on type collisions; and

WHEREAS, Transportation Engineering staff proposed the installation of a concrete barrier in the center of the road, installation of sidewalk on the east side of Ulric Street, and installation of pedestrian ramps to meet ADA standards; and

WHEREAS, the City applied for and was awarded a Grant totaling \$803,700 from the Federal Highway Safety Improvement Program (HSIP), in addition to a \$90,000 grant match of State-Prop 1B funds currently available in the annual allocation for guardrail installation: NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or designee, is authorized for and on behalf of the City to make an application to Caltrans and to take all necessary actions to secure funds for an amount not to exceed \$803,700 in federal funds for the Ulric Street between David Street and Fashion Hills Boulevard Improvements Project.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept, appropriate and expend an amount not to exceed \$803,700 if the grant funding is secured.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to establish a special interest-bearing account for the grant, if required.

BE IT FURTHER RESOLVED, that Fiscal Year 2013 Capital Improvements Program Budget is amended by increasing CIP A-IE.00002, Guardrails, Grant #1000394-2013, and to appropriate and expend an amount not to exceed \$803,700, A-IE.00002, Guardrails, Grant #1000394-2013, State (federal awarded), for improvements to Ulric Street between David Street and Fashion Hills Boulevard, contingent upon receipt of a fully executed grant agreement and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$90,000 from CIP A-IE.00002, Prop 1B Guardrails, Grant #1000292-2010, within Fund 600001, State funds, for the purpose of funding grant match requirements.

BE IT FURTHER RESOLVED, that the City Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.
