DATE OF FINAL PASSAGE JUL 30 2013

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE EXPENDITURE OF \$15,250
TO FUND THE ADDITIONAL COSTS REQUIRED FOR
WATER AND SEWER EXTENSIONS ACROSS MARINE
CORPS AIR STATION (MCAS) MIRAMAR.

WHEREAS, on August 4, 2011, the City Council, via Resolution Number R-306975,
approved the acquisition and extension of water and sewer easements (NOy(R)-57585 and
N6247480RP00P39) across MCAS Miramar for \$22,500; and

WHEREAS, as a result of a change in the United States government's processing
structure for easement extensions, the costs for the previously approved easements extensions
rose from \$22,500 to \$37,750; said increased costs include legal and cadastral review, appraisal
and an Environmental Condition of Property (EPC) review; and

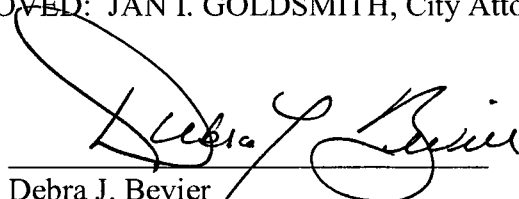
WHEREAS, this action requests an additional \$15,250 to supplement the previously
approved amount of \$22,500 for the easements extensions; NOW, THEREFORE,

BE IT RESOLVED, that the Chief Financial Officer is authorized to expend a total of
\$15,250 (\$7,625 from Water Utility Operating fund 700011 and \$7,625 from Municipal Sewer
Revenue Fund 700000) to fund the additional costs required for a water and sewer easement
extension across Marine Corps air Station (MCAS) Miramar. Said \$15,250 will supplement

funds previously authorized by Resolution R-306975, dated August 4, 2011, for the two easements.

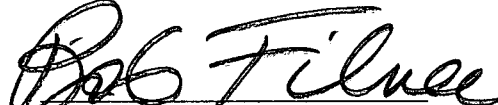
