A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CORRECTING RESOLUTION 307962 IN ORDER TO PROPERLY ACCEPT FUNDS FROM THE ASSISTANCE TO FIREFIGHTERS GRANT.

WHEREAS, on January 30, 2013 the City Council passed Resolution 307962; and WHEREAS, that resolution was meant to allow the City to accept grant funds from the Assistance to Firefighters Grant; and

WHEREAS, the resolution language accepting those funds was incorrect; and WHEREAS, a second resolution is needed to correct this error; NOW THEREFORE,

BE IT RESOLVED, that the Mayor or his designee is authorized and directed to apply for, accept, appropriate, and expend \$261,073 for the purchase of 140 high-speed modems and an antenna system to be used for and in emergency response apparatuses from the federal government through the Assistance to Firefighters Grant program.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to accept reimbursement funds of \$261,073 from the federal government through the Assistance to Firefighters Grant program.

BE IT FURTHER RESOLVED, the Chief Financial Officer is authorized and directed to accept, appropriate, and expend \$261,073 in grant funds from grant number 1000030-2012 and \$65,267 in matching funds from the City's General Fund 10000/1912170011/513104.
