

RESOLUTION NUMBER R- 308385DATE OF FINAL PASSAGE AUG 05 2013A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO SUPPORTING THE PASSAGE OF CALIFORNIA
SENATE BILL 391.


WHEREAS, the purpose of this Resolution is to confirm that the City Council supports the passage of California Senate Bill 391, entitled the California Homes and Jobs Act of 2013 (SB 391); and

WHEREAS, SB 391 would impose a \$75 fee on the recording of real estate related documents, except for those documents recorded in connection with a transfer subject to a documentary transfer tax, and would place the proceeds into the California Homes and Jobs Trust Fund to be appropriated by the California Legislature for the development, acquisition, rehabilitation, and preservation of affordable housing, including emergency shelters, transitional and permanent rental housing, homeownership opportunities, and foreclosure mitigation; NOW, THEREFORE;

BE IT RESOLVED, by the Council of the City of San Diego, that the Council supports the passage of California Senate Bill 391, entitled the California Homes and Jobs Act of 2013, in the form included as Attachment A to the Staff Report No. 13-14, provided that it is modified to

specify that a formula based procedure, and not a competitive procedure, shall be used for distribution of the funds on deposit in the California Homes and Jobs Trust Fund established by section 50471 of the California Health and Safety Code.
