A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AN AS NEEDED SERVICE AGREEMENT WITH NATURES IMAGE, INC. FOR THE OPEN SPACE BRUSH MANAGEMENT PROGRAM.

WHEREAS, the Open Space Division of the City of San Diego Park and Recreation Department (Open Space Division) manages approximately 904 acres of open space lands located within 100 horizontal feet of habitable structures; and

WHEREAS, among other duties related to open space land management, the Open Space Division is responsible for conducting brush management on City owned open space, on a bi-annual basis, adjacent to privately-owned lots which are developed with previously conforming structures built prior to establishment of the City's first brush management regulations in 1989; and

WHEREAS, on September 7, 2012, the City issued RFB No. 10025675-13-W for as needed brush management services within the Open Space Division managed lands citywide to help meet the City's goal of bi-annual brush management; and

WHEREAS, Natures Image, Inc. submitted a bid (Bid) in response to RFB No. 10025675-13-W; and

WHEREAS, the Natures Image, Inc. Bid was the lowest responsible and reliable bid;
NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

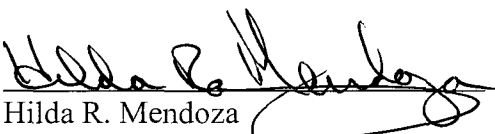
1. That the Mayor or his designee is authorized and directed to execute, for and on behalf of the City, the Memorandum of Agreement with Natures Image, Inc. (Bid Number

10025675-13-W), on file in the Office of the City Clerk as Document No. RR- 308388
(Agreement), under the terms and conditions set forth in the Agreement for as needed brush
management services having an initial term of one year for an amount not to exceed \$1,534,500,
provided that the Chief Financial Officer first furnishes one or more certificates that the funds
necessary for expenditure are, or will be, on deposit in the City Treasury.

2. That the Mayor or his designee is authorized to exercise up to four one-year
contract extension options for the Agreement provided that the Chief Financial Officer first
furnishes one or more certificates that the funds necessary for expenditure are, or will be, on
deposit in the City Treasury.

3. That the Chief Financial Officer is authorized to expend an amount not to exceed
\$8.5 million over five years from Fund No. 100000, Open Space Brush Management Program
for the purpose of funding the Agreement, contingent upon adoption of the brush management
budget for the applicable fiscal year, and provided that the Chief Financial Officer first furnishes
one or more certificates that the funds necessary for expenditure are, or will be, on deposit in the
City Treasury.

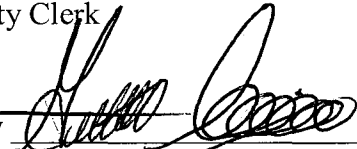

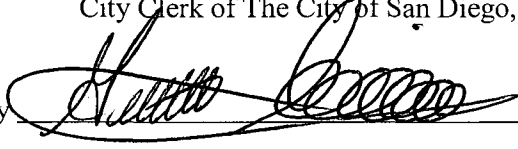
