A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ACCEPTING AB 109 GRANT FUNDS FOR SAN
DIEGO POLICE DEPARTMENT FRONT-LINE
INTERVENTION SERVICES.

WHEREAS, in 2011, Governor Edmund G. Brown, Jr. signed Assembly Bill (AB) 109, also known as the Public Safety Realignment Act; and

WHEREAS, the object of the bill was to reduce the population of low-level inmates cycling in and out of state prisons as ordered by the United States Supreme Court; and

WHEREAS, non-violent, non-serious, and non-sex offenders would serve their sentences in county jails instead of state prisons; and

WHEREAS, today the impact of this action is being felt at the local level as parolees are being released to Post-Release Community Supervision coordinated by the San Diego County Chief Probation Officer in cooperation with each local police agency; and

WHEREAS, prior to AB 109, these parolees would have remained under state parole supervision; and

WHEREAS, subsequently the Governor and State Legislature included \$24,000,000 in the state's 2013-2014 fiscal year budget to be distributed to cities and counties through the state; and

WHEREAS, this allotment (referred to as AB 109 funds) is intended to help local agencies address the need for front-line intervention services as a result of the increased burden on local police departments/sheriffs for Post-Release Community Supervision; and

WHEREAS, the state authorized the Board of State and Community Corrections (BSCC), in consultation with the Department of Finance, to disburse the funds on a formula-based allocation proposed by the California Police Chiefs Association; and

WHEREAS, the BSCC delegated the disbursement of the funds to the collective decision of the local enforcement agencies within the county; and

WHEREAS, through this process, the City of San Diego was chosen to serve as the fiscal agent for the amount of \$1,698,528, which was the amount allocated for the municipal police departments located within the County of San Diego, as well as the San Diego County Sheriff; and

WHEREAS, the county's municipal police departments and the Sheriff entered into a Memorandum of Agreement, dated June 24, 2013, to memorialize the receipt and distribution of these funds; and

WHEREAS, the San Diego County Police Chiefs Association and the San Diego County Sheriffs Association agreed that the \$1,698,528 allocation would be distributed based on the respective population of each of the cities and the unincorporated areas; and

WHEREAS, this distribution provides \$714,005 to the City of San Diego, based on the City having 42.04% of the population within San Diego County; and

WHEREAS, this action will allow the City of San Diego Police Department to accept the AB 109 funding of \$714,005, and provide the AB 109 fund distribution to the other cities and the County of San Diego Sheriff; and

WHEREAS, the San Diego Police Department will use the funds for increased overtime as a result of the requirements for Post-Release Community Supervision; and


WHEREAS, there is no specific timeframe in which the funds need to be spent, nor is there any specific reporting requirement related to this allocation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Chief Financial Officer or his designee is authorized to serve as the fiscal agent and accept funds specifically provided by the California Board of State and Community Corrections to provide enhanced front-line intervention programs and distribute those funds to the County of San Diego Sheriff and the other police agencies within the County of San Diego, per the Memorandum of Agreement, and as directed by the Board of State and Community Corrections.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept, appropriate, and expend \$714,005, specifically provided by the California Board of State and Community Corrections in the fiscal year 2013-2014 allocation, and any additional funds, including any amendments, extensions, renewals, or subsequent funding to the county, for a period of up to five years, for the San Diego Police Department in the Police Department (1914) General Fund (100000).
