WHEREAS, pursuant to that authority, CEQA Guidelines sections 15300-15333 list the categorical exemptions promulgated by the California Office of Planning and Research and adopted by the Secretary of the California Natural Resources Agency for those classes of Projects which have been determined not to have a significant effect on the environment; and

WHEREAS, the Development Services Department has established that the sale of Cityowned real property located at 7629 Jamacha Road in San Diego, California and identified as Assessor's Parcel Number 581-095-18 (Property), is categorically exempt from CEQA pursuant to CEQA Guidelines section 15312 and that no exception to the exemption, as set forth in CEQA Guidelines section 15300.2, applies to the sale; and

WHEREAS, the Council has been informed that the Property will not necessarily be used for any certain purpose in the future and no specific planning or development plan exists informing such future uses and that any future development constituting a project on the subject

sufficient details regarding any such development are actually available, in accordance with

CEQA Guidelines Section 15004; and

BE IT RESOLVED, by the City Council of the City of San Diego, using its independent

judgment, that authorizing the sale of City-owned real property located at 7629 Jamacha Road in

San Diego, California and identified as Assessor's Parcel Number 581-095-18, is categorically

exempt from CEQA pursuant to CEQA Guidelines section 15312 and that an exception to the

exemption does not apply under CEQA Guidelines section 15300.2.
