A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO TO APPROVE THE PROPOSED SPECIAL
EVENT SPACE FEES SCHEDULE FOR THE SAN DIEGO
PUBLIC LIBRARY CENTRAL LIBRARY AND DIRECT THE
CITY CLERK TO ADD THE CENTRAL LIBRARY SPECIAL
EVENT FEES

WHEREAS, the City of San Diego Fiscal Year 2014 Fee Schedule lists the fees charged to rent meeting room space in the City's San Diego Public Library buildings; and

WHEREAS, the City has constructed a new Central Library scheduled to open on September 28, 2013; and

WHEREAS, the new Central Library incorporates meeting rooms and special events space that the former Central Library building lacked, including a large auditorium, special events rooms, larger meeting rooms, and open spaces on the first floor and top floor; and

WHEREAS, in order to make these spaces available for rent to the public for meetings, cultural, and other special events, the Library Director proposes the modification of the existing fee schedule to add rental fees for these spaces, as set forth in the San Diego Public Library Central Library Special Event Space Fee Schedule, City Clerk Document No. RR-308400; and

WHEREAS, the anticipated rental income will be used to offset increased operating costs for the Central Library; and


WHEREAS, to formulate reasonable fair market rates designed to encourage public use and generate revenue, Library staff surveyed rental rates for similar spaces located in the City of San Diego and in public libraries in other major cities; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the proposed special event space fees schedule for the San Diego Public Library Central Library is approved.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to amend the City Ratebook to add the Central Library special event space fees.

BE IT FURTHER RESOLVED, that the proposed fee schedule adjustment shall be effective upon adoption of this resolution.




