A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING THE APPOINTMENT OF
WALT EKARD AS INTERIM CITY MANAGER
(CHIEF OPERATING OFFICER)

WHEREAS, San Diego Charter section 265(b)(7) states that the Mayor has the sole authority to appoint the City Manager, subject to Council approval; and

WHEREAS, since about 2006, the working title for the City Manager has been "Chief Operating Officer" and such working title has been reflected in the annual salary ordinance and other City documents; and

WHEREAS, the position of Chief Operating Officer has been vacant since the resignation of Jay Goldstone effective March 1, 2013; and

WHEREAS, effective March 2, 2013, Mayor Filner appointed Scott Chadwick as the Interim Chief Operating Officer who served in that position until July 14, 2013; and

WHEREAS, on July 15, 2013, Mayor Filner appointed Walt Ekard as the Interim Chief Operating Officer; and

WHEREAS, the Council wishes to confirm the appointment of Walt Ekard as Interim Chief Operating Officer to perform those duties and responsibilities of the Chief Operating Officer until the position is filled on a more permanent basis; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the appointment by the Mayor of Walt Ekard as Interim City Manager (Chief Operating Officer) for the City of San Diego, effective on July 15, 2013, is hereby confirmed.
