A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE CITY COUNCIL'S RESPONSE TO THE 2012/2013 SAN DIEGO COUNTY GRAND JURY REPORT ENTITLED "REDEVELOPMENT IS DEAD; LONG LIVE REDEVELOPMENT!"

WHEREAS, on April 30, 2013, the Mayor and City Council received a report from the 2012/2013 San Diego County Grand Jury (Grand Jury) entitled "Redevelopment is Dead; Long Live Redevelopment!" (Report); and

WHEREAS, under California Penal Code section 933(c), within 90 days after the filing of the Report, each public agency which the Grand Jury reviewed, and about which it issued the Report, must comment to the Presiding Judge of the Superior Court on the findings and recommendations pertaining to matters under the control of the agency; and

WHEREAS, the City was granted a 60-day extension to the time period within which it must provide a response to the Report, and the City's response must be submitted to the Presiding Judge by September 27, 2013; and

WHEREAS, the Grand Jury examined several issues relating to the activities of the former Redevelopment Agency of the City of San Diego (Former RDA), the dissolution of the Former RDA, and the winding down of the Former RDA's affairs, and included 15 findings and 12 recommendations in its Report; and

WHEREAS, of the 12 recommendations, six were directed to the Mayor and City Council, and six were directed to the Mayor only; and

WHEREAS, the Independent Budget Analyst has proposed that City Council President Todd Gloria, as interim mayor, and the City Council provide a joint response to the Report, which joint response is incorporated as Exhibit A to IBA Report No. 13-36 dated September 3, 2013; and


WHEREAS, under Charter section 280(a)(1), this Resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and does not affect the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. The Council approves and adopts as its own the proposed response to the 2012/2013 San Diego County Grand Jury Report entitled "Redevelopment is Dead; Long Live Redevelopment!" attached as Exhibit A to the IBA Report.
2. The Council President is authorized and directed, on behalf of the San Diego City Council, to execute and deliver the above-described response to the Presiding Judge of the San Diego County Superior Court no later than September 27, 2013.
