A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A FOURTH AMENDMENT TO THE AGREEMENT WITH CLEAN HARBORS ENVIRONMENTAL SERVICES FOR THE COLLECTION AND DISPOSAL OF HOUSEHOLD HAZARDOUS WASTE.

WHEREAS, in July 2009, the City entered into an agreement with Clean Harbors Environmental Services, Inc., to collect and dispose of the City's household hazardous waste for a term of one year with options to renew the agreement for up to four one-year terms; and

WHEREAS, the City exercised the first three options to renew the agreement and would now like to exercise the fourth option; and

WHEREAS, this item was heard at the Natural Resources & Culture Committee on July 31, 2013, which unanimously recommended approval of the item; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council President, in his capacity under Charter section 265(i), or his designee, is authorized to execute, for and on behalf of the City, a fourth amendment to the agreement with Clean Harbors Environmental Services, Inc., for collection and disposal of household hazardous waste for the period beginning October 1, 2013 through and including June 30, 2014, under the terms and conditions set forth in the Fourth Amendment, on file with the City Clerk as Documents No. RR- 308411.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$580,677 for the above Fourth Amendment, to be expended as follows: \$560,677 from Fund No. 700048 and \$20,000 from Fund No. 700039, contingent on funding
