WHEREAS, the Department requests that this substantial donation be accepted, that the City Comptroller be authorized to establish a special interest-bearing fund to manage this donation, and that the Chief Financial Officer be authorized to expend principal and interest from the fund to support operations and maintenance for Marian Bear Memorial Park; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the City Comptroller is authorized to accept the donation and establish a special interest-bearing fund to support the trust funds received exclusively for Marian Bear Memorial Park.

BE IT FURTHER RESOLVED, that the City Comptroller is authorized to deposit the donation from the Trust into the special fund to support Marian Bear Memorial Park.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend, and the City Comptroller to disburse, principal and interest from the special fund to support operations and maintenance for Marian Bear Memorial Park.
