WHEREAS, in Closed Session on July 29, 2013, the City Council, by the following votes: Yeas, District(s) - 1, 2, 3, 4, 5, 6, 7, 8, and 9, approved settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement on file in the Office of the City Clerk as Document No. RR-308420 NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes:

1. The sum of three hundred fifty thousand dollars (\$350,000) to be paid from the Public Liability Fund No. 7714 in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City, its agents and employees, arising from the Litigation.

2. The Comptroller to issue a check in the amount of \$350,000 payable to Ashley Brooks and her attorney of record Michael R. Marrinan.
