- 2. The Chief Financial Officer to appropriate and expend \$235,000.00 from the Public Liability Fund, Fund 720045, contingent upon the Chief Financial Officer first furnishing

one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. The Comptroller to issue a check in the amount of \$235,000.00 payable to the Keith H. Rutman Client Trust Account.
