A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT BETWEEN INTERINSURANCE EXCHANGE OF THE AUTOMOBILE CLUB AND THE CITY OF SAN DIEGO

WHEREAS, on May 10, 2012, INTERINSURANCE EXCHANGE OF THE AUTOMOBILE CLUB filed suit against the City of San Diego [City] alleging inverse condemnation arising from the backup of the City's main sewer line at 874 Cordova Street in San Diego. Plaintiff brought suit in the San Diego Superior Court. The suit is entitled Interinsurance Exchange of the Automobile Club v. City of San Diego, San Diego Superior Court Case No 37-2012-00097014-CU-PO-CTL[Litigation]; and

WHEREAS, in Closed Session on June 25, 2013, the City Council, by the following votes:

Yeas, District(s) 1, 3, 4, 5, 6, 7, and 9; Nays, None; and absent, District(s) 2 and 8, approved the Settlement Agreement.

WHEREAS, the City Council in closed session on June 25, 2013 authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes:

- 1. The sum of \$89,800 to be paid from the Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City, its agents and employees, arising from the Litigation.
- 2. The Chief Financial Officer to appropriate and expend \$89,800 from the Municipal Wastewater Fund, Fund 700000 contingent upon the Chief Financial Officer first

furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. The Comptroller to issue a check in the amount of \$89,800 payable to the Interinsurance Exchange of the Automobile Club.
