DATE OF FINAL PASSAGE SEP 26 2013

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING A NOTICE OF PUBLIC
HEARING ON PROPOSED ADJUSTMENTS TO WATER
RATES IN ACCORDANCE WITH PROPOSITION 218;
SETTING A DATE FOR THE PUBLIC HEARING; AND
TAKING RELATED ACTIONS.

WHEREAS, the Public Utilities Department prepared Report to the City Council No.
13-070 for the City of San Diego [City] dated August 27, 2013, which describes in detail water
rate increases by the County Water Authority to go into effect January 1, 2014 and recommends
adjustments to the City's water rates; and

WHEREAS, the City's Cost of Service Study [COSS], dated August 20, 2013,
recommends adjustments to the City's private fire service, water base fee, and commodity
charges; and

WHEREAS, the California Constitution, Article XIID, section 6 [Proposition 218]
requires the City to hold a public hearing on any proposed new or increased private fire service,
water base or commodity charge, and to mail written notice at least 45 days prior to the public
hearing; and

WHEREAS, the Natural Resources & Culture Committee considered this matter on
July 31, 2013, and approved moving it to the full Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Council accepts the Cost of Service Study – San Diego Public Utilities
Department Water Fund, dated August 20, 2013, on file with the City Clerk as Document No.

RR- 308430-1

2. That the Council receives the Report to the City Council No. 13-070, dated August 27, 2013, on file with the City Clerk as Document No. RR- 308430-2.


3. That the Council President, in his capacity under San Diego Charter section 265(i), is authorized and directed to notice a public hearing on proposed water rate adjustments in accordance with the requirements of Proposition 218 and the procedures previously adopted by the City Council in Resolution R-302245, except that the notice required by Proposition 218 will be given by separate mailing to the address to which the Public Utilities Department customarily mails the regular customer billing statement, pursuant to California Government Code section 53755.

4. That the Council President, in his capacity under San Diego Charter section 265(i), is authorized and directed to notice said public hearing with the document "Notice of Public Hearing NOV 21 2013", prepared in accordance with the requirements of Proposition 218 and the procedures previously adopted by the City Council in Resolution No. R-302245, except that the notice required by Proposition 218 will be given by separate mailing to the address to which the Public Utilities Department customarily mails the regular customer billing statement, pursuant to California Government Code section 53755.

5. That the public hearing for the City Council to consider the proposed water rate adjustments will be held during the regularly scheduled City Council Meeting of NOV 21 2013 and will be conducted in accordance with Proposition 218 and the procedures previously adopted by the City Council in Resolution No. R-302245.


