A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING OF AN EXTENSION OF SURF  
CAMP CONCESSION PERMITS FOR EIGHT CURRENT SURF  
CAMP CONCESSION VENDORS ON A MONTH TO MONTH  
BASIS FOR UP TO ONE YEAR

WHEREAS, due to the popularity of surfing in San Diego and the overabundance of unregulated surf lesson vendors on City Beaches, the San Diego Lifeguards and Real Estate Assets departments released a request for proposals to invite surf camp vendors to apply for eight concession permits which would last for approximately sixty four months; and

WHEREAS, this Council authorized each of these concession permits via the following resolutions: R-303744, R-303745, R-303746, R-303747, R-303748, R-303749, R-303750, and R-303751; and

WHEREAS, these concession permits were approved on May 28, 2008, and will expire on September 30, 2013; and

WHEREAS, although there is a request for proposals process underway inviting surf camp vendors to bid for concession sites for the next term of these concession permits, the results are not expected until sometime after November 1, 2013; and

WHEREAS, this delay will create a gaps of time where there is no permitted vendor to provide surf camps on City beaches; and

WHEREAS, this gap in service in not in the best interests of either the public or public safety; and

WHEREAS, any extension of the current permits requires Council approval, per the terms of the surf camp concession agreements; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council President in his capacity under Charter section 265(i), or his designee, is authorized and directed to enter into a month to month surf camp concession permit extension with each of the eight current surf camp concession permit holders, namely Surf Dive Inc., Menehune Surf, Inc., Ocean Experience Surf School, Pacific Surf School, Pacific Beach Surf School, Paskowitz Surf Camp, Surfari Surf School, and San Diego Surf School, for a period of up to twelve months beginning October 1, 2013.
