A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE CITY ATTORNEY TO INCREASE THE COMPENSATION TO NIXON PEABODY LLP FOR BOND AND DISCLOSURE COUNSEL SERVICES PROVIDED IN RELATION TO THE PUBLIC FACILITIES FINANCING AUTHORITY OF THE CITY OF SAN DIEGO LEASE REVENUE BONDS AND LEASE REVENUE REFUNDING BONDS, SERIES 2013A (CAPITAL IMPROVEMENT PROJECTS AND OLD TOWN LIGHT RAIL EXTENSION REFUNDING) AND SERIES 2013B (BALBOA PARK/MISSION BAY PARK REFUNDING) IN AN AMOUNT OF \$7,000.

WHEREAS, on March 26, 2013, the City Council adopted Ordinance No. O-20249 authorizing the issuance of the Public Facilities Financing Authority of the City of San Diego Lease Revenue Bonds and Lease Revenue Refunding Bonds, Series 2013A (Capital Improvement Projects and Old Town Light Rail Extension Refunding) and Series 2013B (Balboa Park/Mission Bay Park Refunding)(Bonds) and authorizing the City Attorney to appoint Nixon Peabody LLP to provide Bond and Disclosure Counsel services in relation thereto; and

WHEREAS, the authorized amount for the agreement with Nixon was for \$75,000 in fees and up to \$5,000 in expenses; and

WHEREAS, due to the complexity of the transaction, particularly related to the refundings, Nixon provided services to the City in excess of what was contemplated when Nixon undertook the transaction; and

WHEREAS, Staff recommends increasing the compensation for Nixon by \$7,000 in recognition of the excellent service provided to the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the City Attorney is authorized to increase the amount of compensation for Nixon Peabody by \$7,000 to \$82,000 from \$75,000.
