A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE PROPOSED CHANGES TO THE MISSION BEACH COMMUNITY PRECISE PLANNING BOARD BYLAWS.

WHEREAS, the proposed bylaw amendments submitted by Mission Beach Community Precise Planning Board (MBPPB) contain deviations to Council Policy 600-24; and

WHEREAS, the four proposed bylaw amendments that are deviations are as follows: (1) Article IV, Vacancies, Section 3, the minimum number of board members is revised from 12 to 10; (2) Article VI, Community Planning Group and Planning Group Member Duties, Section 2, is revised to have email distribution of agenda and minutes as the "standard" method of communication, however, U.S. Mail requests will be granted; (3) Article VIII, Planning Group Policies and Procedures, Section 1.c.4, is revised to allow an individual community member, who does not meet the eligibility for the area to be represented to be nominated and elected to represent that area until the next regular election; and (4) Article VIII, Planning Group Policies and Procedures, Section 1.d, sets forth a new method of recalling board members that is unrelated to violations of Council Policy 600-24; and

WHEREAS, other updates that are consistent with the City Council Policy 600-24 are included in the bylaws, but are not discussed here; and

WHEREAS, considerations are provided by City planning staff to assist in evaluating potential ramifications of the proposed deviations; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, hereby approves the Mission Beach Community Precise Planning Board Bylaws with the referenced deviations, a copy of which is on file in the office of the City Clerk as Document No. RR-308454.
