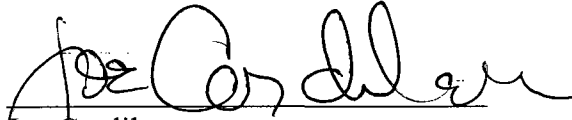
WHEREAS, in closed session on July 16, 2013, the City Council approved and authorized settlement of each and every claim against the City and all other defendants for an amount consistent with the sum set forth below; NOW, THEREFORE, and

BE IT RESOLVED, by the City Council of the City of San Diego, that the sum of two hundred eighty thousand dollars be paid from the Public Liability Fund, Fund No. 720045, in settlement of each and every claim arising from the above-referenced lawsuit of the Rancho San Diego/Jamul Chamber of Commerce Rancho, including interest, costs and fees of any type, including attorney fees against the City of San Diego, its agents and employees, arising from the litigation.

BE IT FURTHER RESOLVED, that the Comptroller to issue a check in the amount of two hundred eighty thousand dollars payable to the Attorney-Client Trust Account of Aguirre, Morris, and Severson, LLP.
