DATE OF FINAL PASSAGE SEP 30 2013

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE CITY COUNCIL'S RESPONSE TO THE 2013 SAN DIEGO COUNTY GRAND JURY REPORT ENTITLED "IMPROVED ACCESS TO LAND SURVEY RECORDS AND MONUMENTS."

WHEREAS, on May 1, 2013, the Mayor and City Council received a report from the 2012-2013 San Diego County Grand Jury (Grand Jury) entitled "Improved Access to Land Survey Records and Monuments" (Report); and

WHEREAS, under California Penal Code section 933(c), within 90 days after the filing of the Report, each public agency which the Grand Jury reviewed, and about which it issued the Report, must comment to the Presiding Judge of the Superior Court on the findings and recommendations pertaining to matters under the control of the agency; and

WHEREAS, the City was granted a 73-day extension to the time period within which it must provide a response to the Report, and the City's response must be submitted to the Presiding Judge on October 11, 2013; and

WHEREAS, of the twelve findings and six recommendations, one finding was directed to the County of San Diego, and eleven findings and six recommendations were directed to the Mayor and City Council; and

WHEREAS, the Independent Budget Analyst (IBA) has proposed and recommends that City Council President Todd Gloria, as interim mayor, and the City Council provide a joint response to the Report, which joint response is incorporated as Attachment 1 to IBA Report No.

13-37REV dated September 25, 2013 (IBA Report) with amendments as set forth in Attachment 2 to the IBA Report; and

WHEREAS, under Charter section 280(a)(1), this Resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and does not affect the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. The Council approves and adopts as its own the proposed response to the 2012/2013 San Diego County Grand Jury Report entitled "Improved Access to Land Survey Records and Monuments" attached as Attachment 1 to the IBA Report with the incorporation of amendments set forth in Attachment 2 to the IBA Report.

2. The Council President is authorized and directed to execute and deliver the above-described response to the Presiding Judge of the San Diego County Superior Court no later than October 11, 2013.
