BE IT RESOLVED, that the authorization for the prior cooperative agreement pursuant to Resolution No. R-308126, on file in the Office of the City Clerk as Document No. RR-308126-2, is hereby rescinded; and the remaining authorizations and approvals of Resolution No. R-308126 continue in full force and effect.

BE IT FURTHER RESOLVED, that the Council President, in his capacity under Charter section 265(i), or his designee, is authorized and directed to execute, for and on behalf of City,

the New Cooperative Agreement, on file in the Of	fice of the City Clerk as Document No. RR-
