A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING MEDIAN MODIFICATIONS ON
MISSION BOULEVARD BETWEEN SAN FERNANDO PLACE
AND VENTURA PLACE PROJECT.

WHEREAS, the Mission Beach Precise Planning Board has requested median modifications on Mission Boulevard between San Fernando Place and Ventura Place; and

WHEREAS, the median modifications will consist of the installation of two left-turn pockets within the median; and

WHEREAS, these turn pockets will improve the safety of left turn access into parking lots and reduce congestion; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Chief Financial Officer is authorized to increase Capital Improvements Program Budget amount by \$144,814.00 for CIP A-IG.00001 for median installations on Mission Boulevard between San Fernando Place and Ventura Place.

2. That the appropriation and expenditure of an amount not to exceed \$144,814.00 from Fund No. 400185-Belmont Park/Mission Beach Development Fund, is authorized solely and exclusively for the purpose of providing funds for median modifications on Mission Boulevard between San Fernando Place and Ventura Place, provided that the City Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditures are, or will be, on deposit with the City Treasurer.

3. That the City Comptroller, upon advice from the administering department, is authorized to transfer excess budgeted funds, if any, to the appropriate reserves.


