DATE OF FINAL PASSAGE OCT 22 2013

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO RATIFYING A FIVE-YEAR AGREEMENT WITH SAN DIEGO POLICE EQUIPMENT COMPANY, AND AUTHORIZING EXPENDITURES OVER FIVE YEARS, IN FISCAL YEARS 2010 THROUGH 2015, FOR THE PURCHASE OF BODY ARMOR FOR THE SAN DIEGO POLICE DEPARTMENT.

WHEREAS, the San Diego Police Department (SDPD) prescribes that while on duty and assigned to the field, uniformed personnel shall wear body armor; and

WHEREAS, body armor is issued to all sworn officers upon hire, and replaced every five years to coincide with expiration of the warranty; and

WHEREAS, City Bid No. 9930-10-Q, seeking bids to provide body armor to the SDPD, was competitively bid in Fiscal Year 2010; and

WHEREAS, a contract for body armor was awarded to San Diego Police Equipment Company, Contract No. 4600000124; and

WHEREAS, the contract will be for no more than five years; and

WHEREAS, the City expended \$844,949 in Fiscal Years 2010 through 2013; and

WHEREAS, the City expects to expend approximately \$215,000 in Fiscal Year 2014 and \$100,000 in Fiscal Year 2015; and

WHEREAS, expenditures for Fiscal Years 2014 and 2015 are based upon SDPD estimates for vest replacement and new purchases; and


WHEREAS, the City anticipates spending more than one million dollars over the life of the five-year contract, exceeding the threshold in Fiscal Year 2014; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the contract with San Diego Police Equipment Company for the purchase of body armor, Bid No. 9930-10-Q, Contract No. 4600000124, approved in 2011, is hereby ratified.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$215,000 in Fiscal Year 2014, from the General Fund (100000) for the fourth year of the San Diego Police Equipment Company contract.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$100,000 in Fiscal Year 2015, from the General Fund (100000) for the fifth year of the San Diego Police Equipment Company contract, contingent upon adoption of the Fiscal Year 2015 Annual Budget Appropriation Ordinance, and upon the Chief Financial Officer certifying that the funds necessary for expenditure are or will be available.
