DATE OF FINAL PASSAGE OCT 29 2013

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE FIRST AMENDMENT TO
THE AS-NEEDED COMMUNITY OUTREACH SERVICES
WITH COLLABORATIVE SERVICES.

WHEREAS, the City and Collaborative Services entered into an agreement on October 11, 2011 (Document No. C-15630) to provide as-needed community outreach services for the Public Works Department; and

WHEREAS, this agreement was for a term of two years and compensation not to exceed \$240,000; and

WHEREAS, the City and Collaborative Services now desire to amend the agreement to extend the term an additional two years and increase the value of the contract by an additional \$250,000; and

WHEREAS, as amended, the term of the agreement will be a total of four years, and compensation not to exceed \$490,000. NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the Council President, in his capacity under Charter section 265(i), or his designee, is authorized and directed to execute, for and on behalf of the City, the First Amendment to the Agreement with Collaborative Services for as-needed community outreach community services, under the terms and conditions set forth in the Agreement, on file in the Office of the City Clerk as Document No. RR 308504

2. That the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$250,000, solely and exclusively to provide funds for the above agreement


provided that the Chief Financial Officer furnishes one or more certificates demonstrating that the funds for this expenditure are, or will be, on deposit in the City Treasury.


