DATE OF FINAL PASSAGE OCT 29 2013

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE APPROVAL OF THE FIRST AMENDMENT TO THE AS-NEEDED COMMUNITY OUTREACH SERVICES AGREEMENT H115327 IS STATUTORILY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINES SECTION 15262.

WHEREAS, the City and Collaborative Services entered into an agreement on October 11, 2011 [Document No. C-15630] to provide as-needed community outreach services for the Public Works Department; and

WHEREAS, the City and Collaborative Services now desire to amend the agreement to extend the term an additional two years and increase the value of the contract by an additional \$250,000; and

WHEREAS, the California State Legislature, through the California Environmental Quality Act (CEQA), Public Resources Code sections 21000-21177, has determined that CEQA does not apply to various types of projects listed therein; and

WHEREAS, CEQA section 21084 states that the CEQA Guidelines shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15260-15285 list the statutory exemptions promulgated by the California State Legislature; and

WHEREAS, the Council of the City of San Diego has considered the potential environmental effects of the As-Needed Community Outreach Services Agreement H115327; and

WHEREAS, the Council of the City of San Diego, using its independent judgment, has determined that the project will not have a significant effect on the environment as this action would secure funds for further environmental analysis and not commit the City to any future course of action; NOW, THEREFORE,

BE IT RESOLVED, that the As-Needed Community Outreach Services Agreement H115327 is statutorily exempt from CEQA pursuant to CEQA Guidelines section 15262, Feasibility and Planning Studies.


